

MINUTES OF THE THIRD (3RD) MEETING OF THE COMMITTEE OF CREDITORS OF PREMIA PROJECTS LIMITED (CORPORATE DEBTOR AND A COMPANY UNDER CIRP) HELD ON MONDAY, 19TH AUGUST 2019 AT 04.00 P.M. AT OFFICE NO 209-211,H-17/18,2ND FLOOR, LAXMI NAGAR, VIKASH MARG, NEW DELHI-110092

Meeting Started at 4.30 P.M.

1. CHAIRMAN

Mr. Jitender Arora, Resolution Professional of "Premia Projects Limited", Chaired the meeting, pursuant to Regulation 24(1) of the Insolvency and Bankruptcy Board of India (Insolvency Resolution Process for Corporate Persons) Regulations, 2016. The Chairman has welcomed Authorized Representative present on behalf of the members of the Committee of Creditors in the original meeting held on 19th August 2019. The Chairman gives the permission of starting the meeting with delay of half an hour (i.e. from 4 p.m. to 4.30 p.m.) as the Authorised Representative has conveyed the message of reaching delayed at venue due to traffic jam.

2. TO TAKE A ROLL CALL WHEN EVERY PARTICIPANT IS ATTENDING THROUGH VIDEO CONFERENCING OR OTHER AUDIO AND VISUAL MEANS

The Chairman informed that being the Committee of Creditors is constituted of Financial creditors (class of Home Buyers) only, and Mr. Manish Agarwal, Authorised representative has attended on behalf of them, and the same is confirmed by the Manish Agarwal, Authorised Representative of Committee of Creditors.

3. TO ASCERTAIN THE QUORUM OF THE MEETING IN ACCORDANCE WITH THE PROVISION OF REGULATION 22 OF THE INSOLVENCY AND BANKRUPTCY BOARD OF INDIA (INSOLVENCY RESOLUTION PROCESS FOR CORPORATE PERSONS) REGULATIONS, 2016

The Chairman informed the members of the Committee of Creditors present in the Meeting that as per Regulation 22(1) of the Insolvency and Bankruptcy Board of India (Insolvency Resolution Process for Corporate Persons) Regulations, 2016, the quorum for the meeting of members of the committee shall be at least 33% of the voting rights present either in person or by video conferencing or other audio-visual means. The committee may modify the percentage of voting rights required for quorum in respect of any future meetings of the committee.

The Chairman requested the Authorized Representative to confirm the quorum requirement. Mr. Manish Agarwal, Authorized Representative representing the Committee of creditors thereafter confirmed the quorum requirement and requested to proceed further.

4. TO TAKE NOTE MINUTES OF 2ND COMMITTEE OF CREDITORS HELD ON, 16TH JUNE 2019 & ADJOURNED MEETING OF 2ND COC DATED 17TH JUNE 2019.

The Chairman read the agenda item and placed the Minutes of the 2nd Meeting of Committee of Creditors with Adjourned 2nd Meeting of Committee of Creditors. After discussion, Mr. Manish Agarwal, AR on behalf of the Committee of Creditors takes note of same. After discussion the following resolution is passed in the meeting:-

“RESOLVED THAT the Committee of Creditors do hereby take note of the Minutes for the second meeting of Creditors held on 16th June 2019 and also take the note of the Adjourned 2nd Meeting of Committee of Creditors on 17th June 2019”.

5. TO TAKE NOTE OF THE APPOINTMENT OF MANISH AGARWAL AS AUTHORIZED REPRESENTATIVE

The Chairman further informed the members of the Committee of Creditors of Corporate Debtor that the appointment of Authorized Representative is done at the Adjourned Second Meeting of Committee of Creditors held on 17th June 2019. After discussion, the Committee of Creditors takes note of the same and the following resolution was passed at the meeting:-

‘RESOLVED THAT the Committee of Creditors take note of the appointment of Mr. Manish Agarwal as Authorized Representative on behalf of the Financial Creditors (Home Buyers).

6. TO TAKE NOTE OF THE STATUS OF TAKING OVER OF ASSETS FROM THE OFFICIAL LIQUIDATOR

The Chairman updated the status of taking over of assets from Official Liquidator, and in continuation of the same, an application to Hon'ble High Court as directed by Hon'ble NCLT has been filed. The matter will be listed soon for the hearing. After discussion, the members of Committee of Creditor take note of the same.

“RESOLVED THAT the Committee of Creditors take note of the status of taking over of the assets from the Official Liquidator”.

7. TO TAKE NOTE OF THE UPDATED LIST OF COMMITTEE OF CREDITORS AS ON 12TH AUGUST 2019

The Chairman informed the Committee of creditors that the List of Creditors as on 12th August 2019 read with Corrigendum of same dated 13th August 2019 attached with the Notice & agenda and published on the portal at www.premiaprojects.in is available. The Chairman requested the members of the CoC to take note of the same.

The Chairman further informed the members that a form for Correction / updation of details is available on the portal at www.premiaprojects.in . Any member who finds that details or data punched in the list is not correct, may apply to RP for updation / correction. He further assured the members of the Committee of Creditors that list would be corrected/ updated from time to time as and when any such case comes to in his knowledge on the request of member or suo-motu. After discussion, the Committee of Creditors passes the following resolution:-

“RESOLVED THAT the Committee of Creditors take note of the List of Committee of Creditors as on 12th August 2019 read with the Corrigendum dated 13th August 2019 as circulated and published on the portal at www.premiaprojects.in.”

8. TO TAKE NOTE OF THE PRELIMINARY INFORMATION MEMORANDUM PREPARED BY THE RESOLUTION PROFESSIONAL CONTAINING MATTERS REFERRED TO IN REGULATION 36 (1) (A) OF THE INSOLVENCY AND BANKRUPTCY BOARD OF INDIA (INSOLVENCY RESOLUTION PROCESS FOR CORPORATE PERSONS) REGULATIONS, 2016 AND MATTERS INCIDENTAL THERETO.

The Chairman placed the Preliminary Information Memorandum prepared on the basis of information available & compiled by the Resolution Professional & its consultants during the Corporate Insolvency Resolution Proceeding. The Chairman further submitted that any Member of the Committee of Creditors may take the copy of same subject to the furnishing of the undertaking to Resolution Professional on a judicial stamp paper of Rs. 20/- in pursuant to the Regulation 36 (4) of the Corporate Insolvency Regulation. The format of undertaking is enclosed with the notice & agenda circulated to all the members of the Committee of creditors. The chairman further informed the Committee of Creditors (AR) that some information which is depending upon the decision of Hon'ble High Court regarding Possession of Assets of Company from Official Liquidator, Details of Assets & Liabilities as per updated Books of Accounts; Financial Accounts upto 30th May 2018 are under the process. Such information will be updated in the Information Memorandum in the second stage.

After discussion, the Committee of creditors takes note of the same and passes the following resolution:-

“RESOLVED THAT Committee of creditors take note of the Preliminary Information Memorandum as prepared on the basis of information available & compiled through various sources.”

9. TO TAKE NOTE OF STATUS OF CIRP PROCEEDINGS

The Chairman informed the Committee of Creditors about the status of CIRP proceedings conducted by all the Consultants. The Chairman explained the status of work done by the Accountant, Legal Consultants, Forensic Auditor and Technical Consultant. After discussion, the work done is found satisfactory and the Committee of creditors takes the note of the same.

10. TO TAKE NOTE OF THE PAYMENT SYSTEM DEvised BY RP FOR MAKING PAYMENTS TO CONSULTANTS & RP.

The Chairman informed the Committee of Creditors about the payment system devised for making payments to Consultants and RP. The Chairman explained that this system meets the proper criteria of making payment as all the consultants and RP has done their work with diligently. As we all know that the promoters & directors are absconding in this matter and no cooperation is available from Corporate Debtor side. After so many challenges, the RP has gathered the information from various sources and appointed consultants for working on the same. The RP further stated that the criteria of 25% payment of outstanding amount of approved remunerations & expenses are justified. The Chairman proposed to take the note of same.

Mr. Manish Agarwal, Authorised Representative has provided the details of mails on 20th August 2019, the copy of same is attached herewith (**as annexure-A**). Mr. Manish Agarwal, Authorised Representative has analysis the emails received from the various Financial Creditors (Home Buyers) and as per the record the representation received from such 100 FC's who have requested to add for additional item in the agenda carries the weight age of 21.84%. This includes the representation of FC (Home Buyers) who have given their defending objections against take note of this item. The Chairman further informed Mr. Manish Agarwal, Authorised Representative of Committee of Creditors that being the requisite items for adding the agenda doesn't meet the criteria as per the IBC, 2016, such item cannot be part of the agenda. Further the majority of members of Committee of Creditors have no objection in taking note of the same. Hence, the above item has been noted by the Committee of Creditors.

The Chairman further explained the Committee of Creditors represented by authorized Representative that, we have reached at this stage, because of hard work done by team & Financial Creditors (Home Buyers).

After discussion, the Committee of Creditors takes note of the same.

11. TO DISCUSS THE ROAD MAP AHEAD TOWARDS RESOLUTION OF PROCESS

The Chairman informed the Committee of Creditors the road map ahead from this point. The Chairman explained that now the application has been filed with Hon'ble High Court for seeking directions to direct the Official Liquidator to give the possession of the properties of the Corporate Debtor to Resolution Professional.

Once we get the favorable directions from the Hon'ble High Court, that will push over proceedings and the work which was pending due to this legal complication could be completed. Thereafter, the Preliminary Information Memorandum also gets updated to final stage.

Thereafter the same need to be published and bids are required to be called upon. Once the Resolution Applicants bids over the projects, the Committee of creditors is required to analyze the plans and approve them accordingly. After approval of Committee of Creditors, the same will be submitted for the approval of Adjudicating authority.

After discussion, the Committee of creditors takes note of the same.

B. List of Issues to be voted upon after discussions.

12. SEEKING APPROVAL OF MEMBERS OF COMMITTEE OF CREDITORS FOR FILING ANY APPLICATION WITH THE HONORABLE NCLT FOR EXCLUDING THE TIME/ EXTENSION OF TIME UNDER CIRP PROCESS.

The Chairman informed the Committee of Creditors that as the 180 days provided for the CIR process is going to be expired on 26th August 2019. We are required to file an application with the National Company Law Tribunal for the purposes of excluding the time involved in the legal matters or extending the CIRP time period for the further 3 months or such time as prescribed under the IBC, 2016. The Committee of Creditors represented by Mr. Manish Agarwal Authorized Representative discussed & acknowledges the reason of delay is due to pendency of matter with various Courts, Investigation agencies and other authorities.

After discussion, the given below resolution is proposed for the voting of Committee of creditor.

“RESOLVED THAT the pursuant to the provisions of Sec 12(2) of the IBC, the Committee of Creditors has decided to authorize the Resolution Professional to apply for excluding /extend the time of CIRP proceedings of Premia Projects Limited as the Liquidation Proceedings initiated by High Court by appointing Provisional Liquidator, SFIO investigation Report & Pronouncement of Order by Hon’ble High Court are still pending which has created hurdle in the completion of Corporate Insolvency Resolution Process under IBC, 2016.

“RESOLVED FURTHER THAT the Committee of Creditors do hereby authorize Mr. Jitender Arora, Resolution Professional of Premia Project Limited to file an application with the National Company Law Tribunal for excluding the time lost in various issues which are unavoidable in regard to this matter and/ or extending the time for another 90 days.”

Mr. Manish Agarwal, Authorised Representative of Financial Creditors (Home Buyer) has submitted the results of e-voting as under:-
